

## EXCERPT FROM THE STATUTE OF THE

## **CULTURAL ASSOCIATION AMAZING ROME**

ART . 2) AIMS - The Association respects the character of the democratic, non-political, non-partisan and non -profit aims. The Association rejects any interference, control, influence, dependence on economic groups, religious power centers, companies, political parties. Aims of the Association are:

- a) the protection and enhancement of natural resources and of the historical, artistic and cultural heritage and promoting the correct use of it by the citizens and visitors;
- b) the spread of a multi-ethnic and multi-religious culture, of peace and solidarity between peoples, through the exchange, the cultural development and the enhancement of skills and human and professional capacity;
- c) the prevention of malicious actions against resources (referred to in subparagraph a)) through the promotion of knowledge and culture;
- d) the assertion of the right to culture, to education and to lifelong learning;
- e) the dissemination and disclosure, the study and the scientific research in astronomy and the sciences related to it, such as astrophysics and astronautics;
- f) the development and promotion of social tourism with reference to the elderly and the youth activities;
- g) the promotion of cooperation between those who offer hospitality in tourism in order to enhance and make more accessible the heritage of the environment, art, culture and traditions;
- h) any activity or instrument designed to achieve the above purposes, including activities to raise funds for the achievement of social objectives in accordance with the applicable legislation.

All activities useful to the accomplishment of the purpose listed above can be as example the organisation of seminars, exhibitions, conferences, competitions and congresses, hospitality, guided tours, food and wine tours, sports and cultural activities, or to carry out research and education, produce artworks publishing or audiovisual.

ART . 5) FEES - The annual membership fee is established by the Governing Council. It is not transferable or repeatable.

ART . 6) MEMBERS - people who request to the Executive Council, declaring to accept the present Charter, can enroll regardless of age. Members are entitled to the rights and duties described in this Statute; registration of Ordinary Members is perfected by paying the membership fee in the amount established pursuant to art . 5. Members are divided into: Founders - Ordinary members - Contributing Members - Honorary Members.

Ordinary members are those who will be members of the Association at their request, they are entitled to vote if they comply with the payment of annual dues.

ART. 7) ADMISSION OF MEMBERS - all those who are able to participate in the achievement of social goals, in the opinion of the Board can join the Association; for minors it is necessary a written authorization at the end of admission issued by a parent or other legal guardian. To obtain registration as Ordinary member of the Association such person shall submit to the Board the appropriate registration form. Registration is effective only with the payment of the membership fees, to be made within the time allowed by the Board.

ART . 8) RIGHTS AND DUTIES OF MEMBERS - The ordinary members are required to pay an annual membership fee, the amount of which it will be determined by the Board. Each Member of the association is entitled to vote in the Assembly and enjoys all the rights and privileges accorded by the Assembly, the Statute and any Internal Regulations; He has the right to take part in the studies, the work and all the activities, events and initiatives. Each member is obliged to comply with statutory and internal regulations, as well as to collaborate to achieve the purposes of the Statute , by its commitment.

ART . 9) LAPSE OF MEMBERS - Membership status is lost:

- a) by submitting a writing request to the Board;
- b) by exclusion decided by the Board of Directors, if a member becomes liable for willful misconduct or gross violation of the Statute or the Internal Regulations or conduct prejudicial to the group or incompatible with the belonging to it;
- c) termination of the association, in case of failure to pay the membership fee for two consecutive years or after the expiration of fifteen days from the request for payment made by the association treasurer.

In any event of membership termination to the association, the former member can be no right of redemption of amounts of any kind paid to the Association. In the event of resignation or termination, you can ask to be reintegrate back in the association.

ART . 10) STRUCTURE - are bodies of the association:

the General Meeting - the Executive Council - the Arbitration Committee - the President - Secretary - Treasurer

ART . 11) GENERAL MEETING - The General Meeting is composed of Ordinary Members, Founders and Benefactors, whose right to vote is subject to the regularization of the annual membership fees, is constitutive and sovereign organ of the Association and has power of approval on the matters set out by law and these Articles. The Assembly meets in ordinary session once a year for the convening by the President by notice on the website of the Association.

ART . 21) FINAL CLAUSE - Although not provided for in the present Charter, rules of national or regional law of Lazio are applied.
